Enriching the Community through Head Start and Early Head Start Monitoring

In February 2022, the Head Start and Early Head Start programs began their annual process of self assessment. This process is in place to ensure we are operating in a manner that embraces continuous improvement of the services offered to Head Start and Early Head Start families, which include early childhood development and special services; health; family and community partnership; and transportation. It also appraises program systems, which include program governance; program structure; human resources, training, and professional development; program management and quality improvement; and fiscal.

This assessment process works to effectively gain a better understanding of our systems and services because it includes parents, Policy Council members, Governing Board members, community members, and non-Head Start/Early Head Start staff. Each of the subgroups review files and documents; interview staff at all levels of the program; and view program activities. From their assessment, they conclude program strengths, areas of weakness, and make other comments that will yield the most effective programming.

This year's assessment provided the programs with a record 101 areas of strength and 13 areas needing improvement. From this assessment summary, the Head Start/Early Head Start team identified recommendations for quality improvement. The Quality Improvement Recommendation Report will be submitted to the Policy Council and Governing Board this month for their review and approval. Once approved, each of the Quality Improvement Recommendations will become a Quality Improvement Plan, and the program will begin working to effectively meet the intended outcome/goal. The full report and quality improvement plans is submitted to the Office of Head Start with our Refunding Applications in August and October.

Additionally, the week of April 25, 2022, we participated in a Focus Area 2 Federal Review. This review is conducted by DANYA International Corporation. The review team was made up of four members. Portions of this review were in person, and other parts were remote. There were two review team members who were completely remote, and two who participated in some remote meetings and some in person meetings. The Review Team makes no determination of our program's compliance with OHS Federal Regulations; they provide specific detail about their interviews and documentation reviews and post their findings. The Corporation submits a report to the Office of Head Start (OHS), and OHS sends us our final report. The review team did comment positively about the Governing Board, Policy Council, and Head Start Parent Interviews. They enjoyed seeing the centers and meeting members of our Team. We will receive our review report in the coming month.
