## Summer Food Services Program (SFSP)

Family Enrichment Network is operating a Summer Food Services Program. The Food and Nutrition Services, USDA Summer Food Services Program assists families in obtaining **FREE** nutritious meals and snacks when school is out. Community children 18 years of age and under are welcome to participate in this morning snack and lunch program. The program runs from **July 6, 2021 through August 27, 2021**. Breakfast will be served from **8:00 a.m. to 8:30 a.m.** and lunch will be served from **11:30 a.m. to 12:30 p.m. Monday through Friday** each week at 24 Cherry Street, Johnson City, NY 13790 as a grab and go program.

The grab and go model is set up to ensure that we are keeping children and families healthy given the COVID-19 Pandemic. We do not have a space large enough to ensure proper social distancing, but we are able to offer breakfast and lunch meals through the USDA Summer Food Services Program offered by NYSED. ## Department Spotlight

### Housing and Community Services

Housing and Community Services is comprised of three distinct programs. We work with people with developmental disabilities through OPWDD (Office for People with Developmental Disabilities). We work directly with the city of Binghamton through our ESG program and we offer housing opportunities through our housing program.

Family Enrichment Network's ESG program, known as the *Caring Homes* program, serves individuals and families at-risk of becoming homeless due to rent arrears and/or utility shutoffs as a result of a hardship. Additionally, we are able to provide a security deposit to those facing eviction. Participants must reside in the city of Binghamton, NY to receive assistance.

COVID-19 impacted many of us throughout 2020-2021. The state has recognized the financial hardship this has caused and has allocated funds to specific regions throughout NYS to financially support families and landlords. The funds will support additional homeless assistance and homelessness prevention activities. Available funds may be used to support costs, including but not limited to: hotel/motel vouchers, rental assistance, housing relocation and stabilization services, security deposits, rental arrears and utility arrears. These funds are available in the city of Binghamton and Chenango County. The program will run for two years.

Most recently in Chenango County, New York State awarded FEN with a one year grant known as ERAP. ERAP, the Emergency Rental Assistance Program, will provide significant economic relief to help low and moderate-income households at risk of experiencing homelessness or housing instability by providing rental arrears, temporary rental assistance, and utility arrears assistance. Households approved for ERAP may receive up to 12 months of rental arrears payments for rents accrued on or after March 13, 2020, up to three months of additional rental assistance if the household is expected to spend 30% or more of their gross monthly income to pay for rent.

In March 2021, we opened the doors to our first homeless housing project, *Housing Connections*. *Housing Connections* provides 19 supportive housing units, comprised of four one-bedroom apartments, ten two-bedroom apartments, four three-bedroom apartments, and one four-bedroom apartment. The program prioritizes homeless youth ages 18-25 years old; formerly incarcerated (non-violent offenders); survivors of domestic violence; people with an intellectual or developmental disability; chronically homeless; and disabled military veterans who have an unmet housing need. Supportive services will include: rental assistance, trauma informed assessments and case management, adult literacy, parent education, child care, job readiness training, digital literacy training, financial literacy, housing education, referrals to substance abuse and mental health counseling, benefit advocacy, life skills training, and transportation.

## Department Spotlight, Continued

In addition to Housing Connections, we own three single family homes that we rent to individuals and families. We have two properties located on Roberts Street (11 Roberts St and 51 Roberts St.) as well as a single family home located at 241 Charles Street.

Under the Community Services umbrella we provide Home and Community Based Waiver Services (HCBS). These services are funded through Medicaid and support individuals who receive services under the Office for People with Developmental Disabilities (OPWDD).

Currently FEN offers Community Habilitation and Community Prevocational services. Community Habilitation Program is designed for adults 18 or older who reside with family or independently in the community. This program aims to build skills that will increase independence in their home as well as providing opportunities for community inclusion. The individual has a direct support professional (DSP) that implements person centered plans based on the individual's needs and abilities to assist and support the person in living as independently as possible.

Community Prevocational services is similar to community habilitation, however it focuses on employment skills. The job specialist implements a habilitation plan detailing the person's individualized goals pertaining to community employment. The service setting generally takes places at various voluntary work opportunities within the community. The goal of this service is for the individual to gain employment skills that will assist them in obtaining paid, community employment.
